

ERIE COUNTY SHERIFF'S OFFICE REPORT

The following Grand Island response activity occurred Thursday, Oct. 10, to Wednesday, Oct. 16, as reported by the Erie County Sheriff's Office. ECSSO deputies responded to 342 calls during the period of this report. During this timeframe, deputies responded to five business burglary alarms; one residential burglary alarm; zero mental health calls; one welfare check and handled several
