property in 1953, where three other Gold Star Mothers of that time also stood.

Several Gold and Blue Star Mothers and their families were present at the event Saturday, and all were honored. A welcome address was given by Town of Wheatfield Supervisor Don MacSwan (himself twice a recipient of the Purple Heart for service in Vietnam). Speakers included New York State Sen. Rob Ort and Assemblyman Angelo Morinello (both veterans), and Congressman Tim Kennedy.

The keynote was provided by Fran Davis, Cathy McFarlane and Holly Baker (president of WNY Gold Star Mothers). Eight chapters of this administration remain in Western New York representing the national association created in 1928.

Invocation and closing were offered by the Rev. Denton White, pastor at Holy Ghost Lutheran Church in Bergholz. Town of Wheatfield Historian Justin Higner presented floral bouquets to



each of the Gold and Blue Star Mothers as bagpiper and fireman Kevin Mahoney performed "Amazing Grace." Later in the

evening, Mahoney returned to play taps. Smaller bouquets were also handed out to honored Gold and Blue Star guests.

Besides the wreath, one singular and small floral tribute was laid next to the statue itself in honor of those Gold Star Moth-

ers who could not attend, and for those who have passed on since 1928.
