Reader recipe for hunter's stew

Thanks to Sharon McLaughlin for sharing her family recipe.

In a Dutch oven, brown 2 pounds of ground venison in 2 tablespoons of oil. Drain off the fat.

Add:

- 1 large or 2 medium zucchinis, cut into large chunks
- 4-5 potatoes, peeled and chunked
- 1 large onion
- 1 large carrot
- 1 large green pepper – all cut into large chunks
- 2 16-ounce cans of Italian-style stewed or diced tomatoes
- 1 can of mild RO-TEL diced tomatoes and chiles
- 1 tablespoon minced garlic
- 1 bay leaf
- 1 teaspoon salt
- ½ teaspoon pepper (or to taste)
- Simmer, covered, for 1½ to 2 hours.



For a thicker stew, cook uncovered for 30 minutes or more. Substitute any ground meat for the venison. Can't find Italian-style canned tomatoes? Use regular diced tomatoes and add 1 teaspoon of dried Italian seasoning or ½ teaspoon of dried basil and ½ teaspoon dried oregano. Optional: Serve with pita chips and/or sour cream.
