

# Lewiston kickboxer vies for middleweight title

Lewiston's Mike Stevens will be among those competing in "Kickboxing – Muay Thai at its Best" on Saturday, Nov. 8, at The Stage in the Village of Williamsville. Presented by Castricone's Gym of West Seneca and other participating schools, the all-amateur event will feature local kickboxers vying against others from around the state and Canada for titles.

Stevens, who entered the boxing circuit in 2012, has won a number of titles at earlier matches

in Buffalo, Atlanta and Johnson City, Tennessee. Following a hiatus while working out of town, he turned to the sport of kickboxing and soon found a liking, recording three wins in four matches.

Currently training out of Fight Night Boxing in Niagara Falls, Steven said his ambition is to ultimately turn pro. He sees the Nov. 5 match – where he will compete for a middleweight title against challenger John Billingham – as the first step in this process.

"This title fight on Nov. 5 is huge for me, as I can get my name

out there in kickboxing – as I did in the boxing community several years ago," he said. "I plan on fighting in the amateurs for one to two more years before turning pro. I have about 20 fights under my belt, and believe 10-20 more fights will have me prepared for the professional ranks."

He calls the sport of kickboxing one that separates the weak from the strong.

"Kickboxing is not only about athleticism, but it is truly an art form in which determination, commitment, and sacrifice are

of utmost importance," he said. "When looking at a fighter from the outside, the physical training may seem extremely difficult. However, the mental training it takes is even harsher."

"When you're in the ring, there is no going back. Everything you have been working towards for months, all the physical stress your body has gone through, the strict diet, and the intense mental focus. Everything comes down to those five rounds. The spotlight is on you, eyes from everyone you know, watching you. This is it. It's

an eerily calm moment before a fight, yet extreme adrenaline is coursing through your veins. A feeling hard to explain."

An International Sport Karate Association-sanctioned event, the Nov. 5 match will also feature Mackenzie Musgrove competing against Kellie Marin for the super lightweight title.
