NYATEP introduces inaugural Buffalo & Niagara Falls Workforce Leadership Academy fellows

Local leaders selected for program in partnership with Aspen Institute Economic Opportunities Program

The New York Association for Training and Employment Professionals (NYATEP) introduced the inaugural class of a new program designed to improve local economic mobility and workforce development efforts, while presenting innovative solutions to the challenges faced by workers and businesses.

The Buffalo & Niagara Falls Workforce Leadership Academy, a yearlong fellowship developed through a partnership with the Aspen Institute Economic Opportunities Program, engages nonprofit, government, academic and business leaders in a series of retreats and workshops as they work together to advance an innovative and equitable workforce ecosystem.

The Buffalo & Niagara Falls Workforce Leadership Academy is the first in the region and one of six to be launched this year through the support of Walmart, The Harry and Jeanette Weinberg Foundation, and The Ralph C. Wilson, Jr. Foundation. This academy is the latest in a series of Workforce Leadership Academies hosted in communities across the U.S. and Canada.

The 24 members of the Buffalo & Niagara Falls Workforce Leadership Academy Class of 2023 represent a range of nonprofit organizations, business associations, institutes of higher education, training efforts, and public agencies. The academy launches March 23, and will culminate with a collaborative capstone project presentation on Dec. 5.
