

Investigations continue into Porter air fatality

New York State Police and federal traffic safety officials are continuing their investigations into the cause of an airplane crash that occurred Sunday in the Town of Porter, and which took the life of a pilot from Grand Island.

According to New York State Police, a single-engine airplane piloted by Christopher Caruana, age 35, struck power lines and trees just north of Braley Road and crashed into a field shortly after 3 p.m.

"We believe the plane was headed northbound. It struck some trees and powerlines on Braley and crashed just north into the field," Public Information Officer

and Trooper James O'Callaghan told WGRZ-TV Channel 2.

O'Callaghan said the plane crash occurred in an area near the Skydive the Falls Skydiving Center, a private business that operates out of the Shear Airfield on Braley Road. Caruana, who was identified as the pilot ON Monday by the National Traffic Safety Board, had taken off from the private airfield. He was operating a modified single-engine craft known as a Harmon Rocket at the time of the crash. The plane is described as a performance aircraft that offers "the ultimate aviation experience for recreation and sport flying," according to the Harmon Rocket website.

Caruana is listed as a commer-

cial pilot on the Skydive the Falls website, and identified on Facebook as owner-operator and pilot at Windsor Aviation.

Nearby witnesses said he had just taken off from the Shear Airfield when he encountered difficulty.

"It wasn't anyone from the air strip they are all good; it was a visitor that was taking off and heading home," wrote Tom Siegrist of Ransomville in a Facebook post. "Prayers for him and his family. He was from the Island. Very sad day for a lot of people."

Aaron McCarter, a safety investigator with the NTSB, said witnesses reported a part falling from the plane shortly after Caruana took off. He said NTSB

was waiting for wet and muddy conditions at the crash site to dry for the next stage of the investigation, which would see the wreckage taken to an NTSB facility in Massachusetts.

"We will do a three-dimensional layout on a hanger floor to better facilitate the investigation," McCarter told WGRZ. "We're looking at three things: the human, the machine, and the environment."

He said a full report usually takes the NTSB 12 months to complete.

McCarter said Caruana, "was a well-seasoned pilot, had over 5,000 hours. He was a commercial pilot, well known and respected by his friends at

the airport." He said Sunday's flight was Caruana's first in the Harmon Rocket since Memorial Day.

Tom Neilson of Skydive the Falls said he was not at the skydiving center at the time of the accident.

"I don't know what he was doing that day; I was in Rochester doing tandems," Neilson said. "He wasn't testing anything; he had that for a while" (the Harmon Rocket).

Neilson said he was very sorry to hear of the accident: "I know him; he was a great guy."

He said NTSB investigators are continuing investigations at the site.
