

## LEWISTON POLICE BLOTTER

The following activity occurred Monday, May 29, to Sunday, June 4, as reported by the Lewiston Police Department. LPD reported 243 response calls during this period. For more information on arrests and other activity, visit the Lewiston Police Department's mobile app or its page on Facebook.

### Monday, May 29

- **500 block of Sandlewood Drive, noise complaint** – Caller to 911 reported two cars in the area driving fast and playing loud music. Patrol checked the area and said no loud vehicles were found.
- **4700 block of Perry Court, suspicious activity** – Caller to 911 reported an unknown subject keeps ringing the doorbell; ongoing problem. Caller said a similar incident occurred the previous Friday and was unsure if others in the neighborhood had the same problem. Caller said she was going to install cameras. Patrol checked the area with negative results.

- **4600 block of Townline Road, suspicious activity** – Caller reported a college-aged female in a black vehicle was in the area going door-to-door. Caller said the woman was a college student from

Nebraska, possibly selling books and that she asked to use the bathroom at the residence. Subject left the area heading southbound on Townline Road. Patrol responded.

- **5800 block of Military Road, theft** – Caller stated their disgruntled cousin was upset at U.S. flags being placed on cemetery gravesites and removed the flags. Caller said the advised the cemetery of the incident and was waiting to hear back. Caller said she knows who took the flags but did not have proof. Patrols responded and cleared the call without further incident.

- **100 block of N. Water Street, assist** – Caller to 911 said juveniles in swimsuits were jumping into the water and concerned of their safety. Patrols responded.

- **Swann/Dickersonville road, MVA, property damage** – Caller to 911 reported a two-vehicle accident. Patrol responded; driver taken into custody for aggravated unlicensed operation and released on appearance tickets for Lewiston Town Court. No tows; report taken.

Violations per stop were driver cited for failure to obey a traffic control device; and driver, speed in zone, vehicle clocked at 43 mph in a 30 mph zone.
