

LEWISTON POLICE BLOTTER

The following activity occurred Saturday, July 22, to Friday, July 28, as reported by the Lewiston Police Department. For more information on arrests and other activity, visit the Lewiston Police Department's mobile app or its page on Facebook.

- Saturday, July 22**
- **4200 block of Dickersonville Road, damage to property** – Caller reported damage to a fence from the town Highway Department vehicle. Patrol responded; report taken.
 - **Military/Upper Mountain roads, MVA-property damage** – Caller to 911 she struck a vehicle, rear-ended and left in a panic. Call linked by patrols to a previous hit-run. Report taken.
 - **5300 block of Military Road, Mount St. Mary's Hospital, harassment** – Caller to 911 requested a patrol call back. Patrols responded and said patients had been fighting. Report taken.

- **4600 block of Lower River Road, assist public** – U.S. Border Patrol reported a tree across the roadway; patrol responded.

Violations per stop were registered owner cited for speed in zone, vehicle clocked at 71 mph in a 55 mph zone, patrol said RO became confrontational with officers; driver, speed in zone, vehicle clocked at 72 mph in a 45 mph zone; and one in custody for driving while intoxicated, vehicle towed with hold. Uniform and appearance tickets issued for Lewiston Town Court. Patrols issued three warnings to three drivers for motor vehicle violations at other locations.

- Monday, July 24**
- **2000 block of Ridge Road, suspicious activity** – Caller to 911 reported a male wearing a purple shirt, dress pants and holding a bag exited a cab in front of their house. Subject possibly a known male from Canada who was seeking to visit an ill female at the address and was not invited. Responding patrols advised the subject the female did not wish to speak with him, and he left without incident.

- **2900 block of Upper Mountain Road, assist public** – Caller to 911 reported a roommate was locked out of the apartment. Patrol responded and assisted the party.

- **2000 block of Adams Circle – harassment** – Caller reported receiving scam calls asking her to send money; caller believes subjects will come to her house. Patrol advised the resident to ignore the calls.

LPD advised by U.S. Customs and Border Protection that they were detaining said vehicle with a male, age 80, who stated he knew the registered owner. Patrol reported one male in custody and the vehicle was towed for processing. Report taken.

- **Vincentian Drive, Niagara University campus – disturbance non-domestic** – Caller to 911 reported a homeless male, possibly intoxicated was refusing to leave campus or provide information. Description provided. Per Campus Safety the subject left the campus property. Patrol later located the male.
- **Niagara Scenic Parkway/Pletcher Road, vehicle/traffic stops** – Calls officer initiated. Patrol reported two drivers cited for speed in zone violations. - **700 block of Northridge Drive, check welfare** – Female caller to 911 said she needed help and sounded in distress. Patrol responded and said the female needed help with her TV; no EMS assistance needed.
