

## LEWISTON POLICE BLOTTER

The following activity occurred Monday, Aug. 21, to Tuesday, Aug. 29, as reported by the Lewiston Police Department. LPD reported 271 response calls during this period. For more information on arrests and other activity, visit the Lewiston Police Department's mobile app or its page on Facebook.

### Monday, Aug. 21

- **1000 block of Upper Mountain Road, suspicious activity** – Caller to 911 said a strange male wearing a blue vest was on the property checking meters; subject did not have a badge or ID. Video provided. Patrol checked with National Grid; male in question was a meter reader.
- **Location not listed, suspicious activity** – Patrol stopped a vehicle in an unnamed local park for being on the premises after dark. A vehicle check found it had a suspended/revoked registration for non-payment of tolls. Registered owner said she was addressing the matter with the state DMV and was unaware the suspension affected all of her vehicles.
- **2300 block of Ridge Road, ordinance violation** – Caller to 911 reported an unattended burn. Patrol found the property owner was onsite; fire being extinguished.
- **Grove Street/Townline Road, vehicle/traffic stop** – Call officer initiated. Registered owner cited for an equipment violation. Uniform traffic ticket issued for Lewiston Town Court. Patrols issued warnings to seven other drivers for violations at different locations.

### Tuesday, Aug. 22

- **Center/N. Eighth streets, MVA-property damage** – Officer initiated call. Patrol said the driver of vehicle No. 1 drifted past a stop sign while attempting to make a left turn in traffic; driver backed up and bumped into vehicle No. 2, resulting in minor damage. Information exchange forms issued to drivers.
- **700 block of Center Street, theft** – Caller to 911 reported a theft at a business; male suspect wearing camouflage fled the scene. Caller has video; patrols responded, report taken.

- **Niagara Scenic Parkway/Pletcher Road, vehicle/traffic stop** – Call officer initiated. Registered owner cited for speed in zone, vehicle clocked at 85 mph in a 55 mph zone. Patrol advised the driver for stopping in the middle traffic lane. Uniform traffic ticket issued for Lewiston Town Court.
- **2200 block of Saunders Settlement Road, Niagara Wheatfield High School, disturbance non-domestic** – Unidentified male caller stated two parents were arguing and harassing others at the football field; caller refused to provide further information. Caller said the incident is an ongoing issue and the parents were told not to return due to their inappropriate behavior. Subjects gone on patrols arrival; caller advised to recontact LPD if subjects return.
- **Locations on the 1700 block and on the 2200 block of Saunders Settlement Road, vehicle/traffic stops** – Calls officers initiated. Violations per stop were driver cited for faulty headlamp; and registered owner, speed in zone, vehicle clocked at 65 mph in a 45 mph zone. Registered owner became very confrontational as patrol approached her vehicle. Uniform traffic tickets issued for Lewiston Town Court. Patrols issued warnings to six other drivers for violations at different locations.

- **2200 block of Saunders Settlement Road, suspicious activity** – Caller to 911 reported two men, one older the other younger, in a minivan with a woman who seemed upset. Caller could not provide license plate information. Patrols responded.
- **Niagara River, marine search and rescue** – LPD advised by U.S. Coast Guard; patrols responded.
- **Niagara Scenic Parkway/Ridge Road, vehicle/traffic stop** – Call officer initiated. Registered owner stopped for speed in zone, vehicle clocked at 75 mph in a 55 mph zone. Patrol said the driver was a repeat offender who had been cited for speed in zone at the same location on June 30; warning issued for latest offense.
