The Niagara Falls Blues Festival will return for its 14th year of programming on Old Falls Street USA on Sept. 15-16. The event will be held in memoriam of Toby Rotella, the founder of the festival who passed away in March.

"Niagara Festival and Entertainment Group, in partnership with Old Falls Street, will continue Toby's legacy of bringing first-class blues entertainers to our Niagara Falls Blues Festival with the help of our dedicated volunteers, partners and generous donors," said Sherry Kushner, assistant enter-
