•As Lewiston-Porter enters the final month of the 2020-21 school year, the calendar and our schools are full. Students, pre-K through grade 12, are back on campus five

days per week. Traditional end-of-year events are being planned throughout the buildings and the Lewiston-Porter community.

Pre-K, kindergarten and multi-age "graduations" along with moving up events – second/third grade (PEC to IEC); fifth grade (IEC to middle school); and eighth grade (middle school to high school) – celebrate the transition from one building to the next.

These are milestone moments for Lew-Port's students and families. We are happy to have each of these traditions return this year. The events will take place at the classroom (rather than grade) level, in keeping with current restrictions. Watch for the full calendar of events in the next "Loop."

•Lewiston-Porter is very grateful that, as restrictions on events ease, the Class of 2021 will be able to have traditional graduations events this year. The senior prom will be held at the historic Wurlitzer venue, in North Tonawanda, on Friday, June 18.

Commencement will take place in the outdoor amphitheater at Artpark on Friday, June 25. A rain date is set for Sunday, June 27. Attendance will be restricted to graduates plus four family members.

Families should follow all guidelines as established by Artpark/New York State Parks and watch closely for updates as these guidelines continue to change quickly.

•The Board of Education will

meet at 6 p.m. Monday, June 14, for a work session, then meet for the final meeting of the 2020-21 school year at 6 p.m. Monday, June 21. The annual organizational meeting – the first meeting of the 2021-22 school year – will be held at 6 p.m. Thursday, July 1. Meetings are now open to public attendance and we encourage community members to join us.

Going forward, Board of Education meetings will continue to be livestreamed to allow the community to engage remotely. Recordings and transcripts of each meeting are then posted to the website (go to the Board of Education page, then "Virtual Board of Education Meetings"). Meeting videos are also found on the Lew-Port YouTube channel.
