

North Tonawanda fully reopening City Hall

North Tonawanda Mayor Arthur G. Pappas released a statement announcing City Hall would allow regular walk-in traffic starting Tuesday, May 25:

“As I am sure many of you are aware, guidelines have recently changed in New York. After consulting with the Niagara County Department of Health, and re-

viewing policies with department heads, we are allowing walk-in traffic in city buildings again starting Tuesday, May 25. For the time being, we are still requir-

ing people to wear masks and maintain social distance when possible. We are also still asking visitors to sign contact tracing sheets when they arrive at the de-

partments where they are doing business.”

Until now, City Hall had only been open by appointment.
