NOTICE OF ANNUAL SCHOOL DISTRICT PUBLIC HEARING AND VOTE

NOTICE IS HEREBY GIVEN that, pursuant to Executive Order 202.26, issued by Governor Cuomo on May 1, 2020, an adjourned public hearing for the qualified voters of the Starpoint Central School District (the "District") of the Towns of Pendleton, Cambria, Lockport, Wheatfield and Royalton, Niagara County, New York on the 2020-2021 budget and expenditure of funds will be held on Monday, June 1, 2020 commencing at 6:00 P.M. Eastern Daylight Saving Time. The adjourned public hearing will be conducted remotely, and instructions for viewing will be posted on the District website at <https://ny02205570.schoolwires.net/>.

TAKE FURTHER NOTICE that the Annual School District Vote of the District will be held Tuesday, June 9, 2020, for the purpose of voting on a proposition concerning expenditures for the fiscal year 2020-2021, an election for the Board of Education membership, and for the transaction of such other business as is authorized by law.

TAKE FURTHER NOTICE that Pursuant to Governor Cuomo's Executive Order 202.26, the vote will be conducted by absentee ballot only. The District Clerk will mail absentee ballots

to all qualified voters. The absentee ballots must be returned by mail no later than 5:00 P.M. on Tuesday, June 9, 2020 to the Office of the District Clerk at the District's Administrative Offices located at 4363 Mapleton Road, Lockport, New York. Voters who do not receive absentee ballots by May 26, 2020 should immediately contact the District Clerk via email at dszpaicher@starpointcsd.org or telephone at 716-210-2352 to request an absentee ballot.

TAKE FURTHER NOTICE, that the election of four (4) members of the Board of Education also shall be held at the above time and place to fill four (4) positions on the Board; three (3) seats each for

three-year terms and one (1) seat for a two-year term commencing on July 1, 2020. Requirements to run for a seat this year have been revised for this year. Those interested running for a board of election seat and getting on this year's ballot should contact the District Clerk by May 11, 2020 by 5:00 pm at dszpaicher@starpointcsd.org or by calling 716-210-2352 for further information.

TAKE FURTHER NOTICE that the Board of Education of this District will have prepared and completed a detailed statement in writing of the amount of money which will be required for the ensuing fiscal year 2020-21, for school purposes, specifying the several purposes and amount of each. The amount of each purpose estimated necessary for payments to Boards of Cooperative Educational Services shall be shown in full, with no deduction of estimated state aid. The amount of State Aid provided and its percentage relationship to the total expenditures shall also be shown. Said statement will be available, upon request, from the Office of the District Clerk, during the fourteen days immediately preceding, and the day of, the annual vote except Saturdays, Sundays or holidays, at each of the public school houses of the District. TAKE FURTHER NOTICE that voting on the budget and all propositions shall consist of voting on the following proposition and any other propositions authorized to be voted upon by law.

PROPOSITION NO. 1 – 2020-21 Budget

Shall the following resolution be adopted, to wit:

RESOLVED, that the budget for the Starpoint Central School District (the "District") for the fiscal year commencing July 1, 2020 and ending June 30, 2021 as presented by the Board of Education, is hereby approved and adopted and the required funds therefore are here by appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in the District to be levied and collected as required by law.

TAKE FURTHER NOTICE that military

voters who are qualified voters of the District may apply for a military ballot by requesting an application from the District Clerk. For a military voter to be issued a military ballot, the District Clerk must have received a valid ballot application no later than 5:00 p.m. on May 14, 2020. In a request for a military ballot application or ballot, the military voter may indicate their preference for receiving the application or ballot by mail, facsimile transmission, or electronic mail.

TAKE FURTHER NOTICE that the District is closely monitoring all current and future legal developments as they pertain to District elections and budget votes. Due to the spread of the COVID-19 virus and Governor Cuomo's executive orders mandating the closure of all schools and modifications of school elections, the deadlines and procedures stated herein may change as required by law or consistent with further state guidance.
