BOARD OF EDUCATION RESOLUTION PUBLIC HEARING, BOARD ELECTION, AND BUDGET VOTE STARPOINT CENTRAL SCHOOL DISTRICT

RESOLVED the undersigned Board of Education, Starpoint Central School District, hereby gives notice that the Annual Public Hearing of the school district will be held in the Board of Education Conference Room at Starpoint Central School Building, 4363 Mapleton Road, Town of Pendleton, New York, on Monday, May 11, 2020. The public hearing shall be held at 6:00 p.m. Prevailing Time for the purpose of presentation of the proposed budget for the fiscal year beginning July 1, 2020 and for discussion of the expenditure of funds and the budgeting thereof for the school fiscal year beginning July 1, 2020.

BE IT FURTHER RESOLVED that the Annual Board Election and Budget Vote will be held at the Starpoint High School, 4363 Mapleton Road, Town of Pendleton, New York, on Tuesday, May 19, 2020. There shall be voting for the election of four members of the Board of

Education for three seats each for three-year terms and one seat for a two-year term. The election shall begin at 7:00 a.m., Prevailing Time, and continue until 8:00 p.m., Prevailing Time, or until such time as all those persons present in the voting and registration areas at 8:00 p.m. shall have voted. Voters will be asked for proof of residency pursuant to Education Law Section 2018-c. Such proof may include a driver's license, non-driver identification card, a utility bill or a voter registration card. Upon offer of proof of residency, the school district will also require all persons offering to vote to provide their signature, printed name and address.

BE IT FURTHER RESOLVED that the voting shall be by machine.

BE IT FURTHER RESOLVED that the budget for the school year 2020-21 will be presented as PROPOSITION NO. 1 at the election, held as above specified.

BE IT FURTHER RESOLVED that pursuant to Section 2018 of the Education Law, petitions nominating candidates for the office of member of the Board of Education must be filed with the District Clerk of the Starpoint Central School District, 4363 Mapleton Road, Town of Pendleton, New York, between the hours of 9:00 a.m. and 4:00 p.m., during any business day, but not later than the thirtieth day (April 20, 2020) preceding the annual school district election at which the candidates so nominated are to be elected. In the event that the thirtieth day falls on a Saturday, Sunday or holiday, the last day for filing petitions shall be the next succeeding business day. The petition(s) nominating a candidate(s) must be signed by at least 25 qualified voters eligible to vote in the school district election.

BE IT FURTHER RESOLVED that applications for absentee ballots may be applied for at the Office of the District Clerk, 4363 Mapleton Road, on any weekday, except holidays, between the hours of 8:00 o'clock a.m. (Prevailing Time) and 4:00 o'clock p.m. (Prevailing Time). If the ballot is to be mailed to the voter, the completed application must be received by the District Clerk no later than May 12, 2020. If the ballot is to be delivered personally to the voter at the Office of the District Clerk, the completed application must be received by the District Clerk no later than May 18, 2020. A list of all persons to whom absentee ballots shall have been issued will be available in the Office of the District Clerk during regular business hours on each of the five days prior to the day of the election, except Saturday and Sunday. Such list will also be posted in a conspicuous place at the polling place during the election.

BE IT FURTHER RESOLVED that pursuant to Section 1716 of the Education Law, the Board of Education of said school district will have prepared and completed a detailed statement in writing of the amount of money which will be required for the ensuing fiscal year 2020-21, for school purposes, exclusive of the public monies, specifying the several purposes and the amount of each, and copies of such statement will be available upon request to taxpayers within the said school district during the hours of 9:00 a.m. and 4:00 p.m., from April 27, 2020 to May 19, 2020, at the Principal's Office in each of the school buildings, in the school district Business Office and at the annual election.

BE IT FURTHER RESOLVED that the District Clerk publish notice of the annual public hearing and annual meeting and budget vote in the form of notice attached to this resolution in two newspapers having general circulation within the school district. The publication shall begin at least 45 days prior to the date of the annual meeting and election and continue for a total of four publications.

TAKE FURTHER NOTICE that the Annual School District Vote of the District will be held Tuesday, June 9, 2020, for the purpose of voting on a proposition concerning expenditures for the fiscal year 2020-2021, an election for the Board of Education membership, and for the transaction of such other business as is authorized by law.

TAKE FURTHER NOTICE that Pursuant to Governor Cuomo's Executive Order 202.26, the vote will be conducted by absentee ballot only. The District Clerk will mail absentee ballots to all qualified voters. The absentee ballots must be returned by mail no later than 5:00 P.M. on Tuesday, June 9, 2020 to the Office of the District Clerk at the District's Administrative Offices located at 4363 Mapleton Road, Lockport, New York. Voters who do not receive absentee ballots by May 26, 2020 should immediately contact the District Clerk via email at dszpaicher@starpointcsd.org or telephone at 716-210-2352 to request an absentee ballot.

TAKE FURTHER NOTICE, that the election of four (4) members of the Board of Education also shall be held at the above time and place to fill four (4) positions on the Board; three (3) seats each for three-year terms and one (1) seat for a two-year term commencing on July 1, 2020. Requirements to run for a seat this year have been revised for this year. Those interested running for a board of election seat and getting on this year's ballot should contact the District Clerk by May 11, 2020 by 5:00 pm at dszpaicher@starpointcsd.org or by calling 716-210-2352 for further information.

TAKE FURTHER NOTICE that the Board of Education of this District will have prepared and completed a detailed statement in writing of the amount of money which will be required for the ensuing fiscal year 2020-21, for school purposes, specifying the several purposes and amount of each. The amount of each purpose estimated necessary for payments to Boards of Cooperative Educational Services shall be shown in full, with no deduction of estimated state aid. The amount of State Aid provided and its percentage relationship to the total expenditures shall also be shown. Said statement will be available, upon request, from the Office of the District Clerk, during the fourteen days immediately preceding, and the day of, the annual vote except Saturdays, Sundays or holidays, at each of the public school houses of the District. TAKE FURTHER NOTICE that voting on the budget and all propositions shall consist of voting on the following proposition and any other propositions authorized to be voted upon by law.

PROPOSITION NO. 1 – 2020-21 Budget
Shall the following resolution be adopted, to wit: RESOLVED, that the budget for the Starpoint Central School District (the "District") for the fiscal year commencing July 1, 2020 and ending June 30, 2021 as presented by the Board of Education, is hereby approved and adopted and the required funds therefore are here by appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in the District to be levied and collected as required by law.

TAKE FURTHER NOTICE that military voters who are qualified voters of the District may apply for a military ballot by requesting an application

from the District Clerk. For a military voter to be issued a military ballot, the District Clerk must have received a valid ballot application no later than 5:00 p.m. on May 14, 2020. In a request for a military ballot application or ballot, the military voter may indicate their preference for receiving the application or ballot by mail, facsimile transmission, or electronic mail.

TAKE FURTHER NOTICE that the District is closely monitoring all current and future legal developments as they pertain to District elections and budget votes. Due to the spread of the COVID-19 virus and Governor Cuomo's executive orders mandating the closure of all schools and modifications of school elections, the deadlines and procedures stated herein may change as required by law or consistent with further state guidance.
