family survey. We received over 1,000 responses to a series of questions on how the reopening of schools has gone for our families in the first 10 weeks.

Currently, 278 students are enrolled in the 100% remote model and over 1,700 in the hybrid model (attending in-person two days per week). The results show that, for students in the hybrid model, families feel they have adjusted to this learning model (83.3% strongly agree/agree); they are pleased with the safety measures put in place (94.3% strongly agree/agree); and feel their child enjoys going to school (91.4% strongly agree/agree).

For students in the 100% remote model, families feel the synchronous learning experience is keeping students engaged in the learning process (74.6% strongly agree/agree); that their child can independently navigate their remote synchronous learning (81.7% strongly agree/agree) and they receive support when/if additional help is needed (92.2% strongly agree/agree); and feel their child enjoys remote schooling (79.6% strongly agree/agree).

Despite the unprecedented times and planning, the responses to the survey show Lew-Port student and family expectations are overwhelmingly being met or exceeded. We recognize there is room for improvement, and the feedback, input and suggestions of our families will be used to better the educational processes for all students.

Thank you to all families who responded. A link to the survey results can be found on the Lew-Port website, www.lew-port.com, in the COVID-19 Communication & Information Center.

In addition to regular district business, the board approved the 2020-24 capitol improvement project, and also approved raising the daily rate for substitutes.
