

# Higgins & Filicetti announce \$200,000 COPS grant

Congressman Brian Higgins and Niagara County Sheriff Michael J. Filicetti recently announced a federal grant totaling \$200,000 for Niagara County through the Department of Justice's Office of Community Oriented Policing Services (COPS).

"Responding officers jump into difficult situations with constantly changing variables every day,"

Higgins said. "This grant supports training to further develop tools that can help best prepare officers to deliver safe and effective community policing methods."

Filicetti added, "De-escalation is crucial for law enforcement on every call. This funding will ensure that the citizens of Niagara County have the most highly

trained police officers responding to calls throughout the county. We will also build on the initial training through the simulator funded by this grant."

The grant, awarded specifically through the Community Policing Development Program, will support de-escalation training for two officers who will then work with law enforcement agencies across

Niagara County to provide training and simulation exercises employing proven strategies for responding to challenging calls and keeping communities safe.

In fiscal year 2021, Congress authorized \$31.3 million for the Community Policing Development Program. Niagara County is one of just seven agencies awarded a grant in New York.

The COPS grants were released by the Department of Justice during National Community Policing Week (Oct. 3-9), which celebrates the importance of relationship-building between law enforcement and communities to help create safer neighborhoods.

"As bad actors across the country work to undermine public faith in our electoral institutions, the importance of clear and uniform rules to govern political representation has never been more critical," Hochul

said. "This law will ensure the entirety of our state is governed by rules that are derived directly from the federal and state constitutions and ensure the right to equal participation in our political process."

In the years since this bill was

originally introduced in 2002, the consensus on which standards should govern redistricting has evolved. This bill updates the provisions of MHRL Sec 10(1) (a) (13) (a) and applies those provisions to charter counties by adding identical provisions to

Section 34 of MHRL, which covers charter counties. Several of the standards included in this bill were part of the 2014 amendment to the New York State Constitution, which applied redistricting standards to the drawing of congressional and state legis-

lative districts. By adding these standards to MHRL, they would also apply to the drawing of county legislative districts. The changes set forth in this bill will extend generally accepted standards for representation to all the people of New York.
